

Win2Win.ru: Terms of Use

Last updated: February 28, 2024.

By using the Website <https://win2win.ru/> (hereinafter referred to as the "Website"), you do hereby agree to adhere to the following Rules. If you do not agree to adhere to the following Rules, you may not use the Website and must exit immediately.

1. Definitions of terms

1. Website means an Internet resource which is a collection of information and intellectual property contained in an information system (including computer programs, databases, graphic interface design (design), etc.), access to which is provided from various user devices connected to the Internet through special software for Web browsing (browser) at: <https://win2win.ru/> (including domains of the lower levels related to these addresses) or mobile applications.
2. Operator or Company means Limited Liability Company "WIN2WIN COMMUNICATIONS GROUP OF COMPANIES".
3. User means an individual who accesses the Website and uses the information contained on it.

2. The procedure for exchanging messages between Users and the Operator
